# CQI and Evaluation: Distinct but complementary processes



#### Distinct processes that support each other

#### **CQI**

- Informs process changes
- Ongoing
- Led by program staff



#### **Evaluation**

- Overall assessment of program
- One-time or ongoing
- Led by external evaluator

Our focus today: How can evaluation support internal CQI processes and vice versa?



# Ways to leverage the evaluation partnership for improvement

- / Evaluator is part of the CQI team or is a CQI lead
- / Program team leads CQI but draws on the evaluator partnership in an ad-hoc way
  - To get feedback on data collection tools, such as satisfaction surveys, exit tickets, or interview protocols
  - To analyze data collected as part of road tests or long-term improvement monitoring
- / Program maintains full responsibility for CQI but draws on data from the evaluation



## Distinct uses for data that support each other

Data	Accountability	Improvement	Research
Purpose	Funder reporting, assessing performance	Develop and evaluate changes in practice	Develop and test theories about relationships between variables
Focus of data collection	Performance measures	Implementation and outcomes	Descriptive, outcomes, impact
Frequency	Continuous	Ongoing throughout st in the CQI cycle	hroughout the study, based on research questions
Sample size	100% of those served	Enough data to learn, inform refinements	As much as is feasible with respect to research aims
Nature of data collection	Standardized, comprehensive	Low-stakes, "fail forward" mindset	Meets scientific standards held in the field



# Ways to leverage evaluation data and findings for improvement

#### / Use evaluation data collection efforts

- Focus groups/interviews → What concerns are arising for clients or participants?
- Fidelity logs → Where are facilitators struggling? Or how well are they implementing the curriculum?

#### / Review interim evaluation findings

- Review pre-post findings to flag underperforming outcomes
- If you have a large enough sample, review by subgroups to determine if the program appears to be working better or worse for certain groups


